RE: Fire Department Survey Results

DATE: October 4, 2013

During September, 2013, the Oklahoma County Local Emergency Planning Committee (LEPC) conducted a basic survey of nineteen Oklahoma County Fire Departments. Of the nineteen departments identified, thirteen, or 68% responded. Departments participating included:

- Deer Creek Fire Protection District
- Edmond Fire Department
- Del City Fire Department
- Forest Park Fire Department
- Harrah Fire Department
- Hickory Hills Fire Department
- Jones Fire Department
- Luther Fire Department
- Midwest City Fire Department
- Newalla Fire Department
- Nichols Hills Fire Department
- Nicoma Park Fire Department
- Spencer Fire Department

Following are the results of the responses received:

- 1. What do you feel is the most significant Haz-Mat threat in your jurisdiction? Why?
  - Waste treatment plants or oilfield related issues. Large amount of traffic, closeness of the plants in relation to a creek that floods regularly. (Deer Creek)
  - Fuel tank farms (Del City)
  - Potential rail incidents through our city (Edmond)
  - High pressure gas lines, followed by rail crossing east of town (Forest Park)
  - Railroad through downtown, snow route to I-40 (truck route), feed mill in downtown (Harrah)
  - Highway and railway transportation (Hickory Hills)
  - Battery company, railroad through center of town (Jones)
  - Train derailment, multiple trains daily, previous occurrence (Luther)
  - I-40 highway incident (Midwest City)
  - Nearby railway, accident involving a haz-mat vehicle (Nichols Hills)
  - Arkansas-Oklahoma Railroad due to multiple potential hazards (Nicoma Park)
  - Chemicals being transported by tractor trailers as well as train rail cars, Spencer does not have the equipment to address a haz-mat incident of any kind other than small spills (Spencer)
- 2. Do you feel community members (citizens) are informed on how to respond to this threat?

- 3. If the OK County LEPC hosted an exercise within your jurisdiction with mutual aid partners, what focus would you recommend?
  - Oilfield issues related to H2S, or sewage overflow
  - Ethanol fires
  - Evacuation plans
  - Managing incidents at high-impact occupancies such as schools and golf course
  - Reduce overall threat
  - Containment and evacuation
  - Identify and reduce overall threat and hazards
  - Identifying products, who needs to be contacted, what local jurisdiction's role would be with our capabilities
  - Initial response i.e. staging, communications, public notification and protection
  - Incident involving a haz-mat vehicle
  - Derailment
  - Departments working together and what to expect in a haz-mat situation
- 4. Who would you like to see involved in this exercise?
  - Deer Creek Fire Protection District, OK County Sheriff's Office, associated company (Deer Creek)
  - Midwest City, Tinker, OK City (Del City)
  - Mutual Aid partners (Edmond)
  - Midwest City, Del City (Forest Park)
  - All surrounding cities (Harrah)
  - Fire, Police, EMS, Department of Transportation
  - Any and all responding agencies and businesses and company owners, include responsibilities and procedures (Jones)
  - Surrounding jurisdictions, railway owners and operators, specialty groups (Luther)
  - Area fire and police, emergency management (Midwest City)
  - All mutual aid partners and a Haz-Mat Team, PD, anyone else that could learn from an exercise (Nichols Hills)
  - All agencies that can provide any help and information (Spencer)
