6. Old Business –

6.1 Training Opportunities – L. Kuefler briefed membership on current training opportunities. More information and links to sign up are located under the Training tab on the LEPC website.

6.2 Tabletop Exercise – There are several opportunities for the LEPC to host a FEMA Virtual Table Top Exercise (VTTX) coming up. April 28, 29 and 30th there will be a 4 hour exercise focusing on Tornado Response each day. We may look for a consensus on a day that fits with the majorities schedules. This exercise may be a collaborative effort with the LARC. July 7, 8th, and 9th, FEMA will be hosting a VTTX focusing on Long-term Power Outages. Again, this would be a 4 hour block of time with each day being an independent exercise. The LEPC is also working with COEMA to plan a table top exercise focusing on Crude Oil transportation, to be hosted at the November COEMA Workshop.

6.3 HMEP Grant Requests – Reminder that it is that time of year again. L. Kuefler proposed to the group consideration for participating this year. A possible idea would be a commodities flow study, as the last one conducted was in 2010.
